ASSUMPTION OF RISK AND WAIVER OF LIABILITY RELATING TO
COVID-19: CHSBC VOLUNTEER

The Jewish Community Center of Paramus/Congregation Beth Tikvah (JCCP/CBT) and the Fair Lawn Jewish Center/Congregation B'nai Israel (FLJC/CBI), referred to as the "Synagogues", have put in place preventative measures to reduce the spread of COVID-19; however, the Synagogues cannot guarantee that your child who volunteers for the Community Hebrew School of Bergen County (CHSBC) at the Synagogues, or you, will not become infected with COVID-19. Further, your child, while volunteering for CHSBC at the Synagogues (including when inside the building and outside on the grounds or participating in CHSBC related activities) could increase the risk of your volunteer child or you of contracting COVID-19. You acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that your child or you may be exposed to or infected by COVID-19 by your child volunteering for CHSBC at the Synagogues or participating in CHSBC related activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. You understand that the risk of your child or you becoming exposed to or infected by COVID-19 from your child volunteering for CHSBC at the Synagogues or participating in CHSBC related activities may result from the actions, omissions, or negligence of yourself and others, including, but not limited to, the Synagogues' employees, officers, trustees and volunteers, and participants in CHSBC related activity.

You, on behalf of your volunteer child and for yourself, voluntarily agree to assume all of the foregoing COVID-19 risks and accept sole responsibility for any COVID-19 injury to your child or you (including, but not limited to, personal injury, disability, and death, illness, damage, loss, claim, liability, or expense) of any kind, that your volunteer child or you may experience or incur in connection with your child volunteering for CHSBC at the Synagogues (including when inside the building and outside on the grounds) or participation in CHSBC related activities (Claims).

On behalf of your volunteer child and on your behalf, you hereby release, covenant not to sue, discharge, and hold harmless, the Synagogues, their employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. You understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Synagogues, its employees, officers, trustees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after your child volunteering for CHSBC at the Synagogues (including inside the building and outside on the grounds) or participation in any CHSBC related activity.
