**ASSUMPTION OF RISK AND WAIVER OF LIABILITY RELATING  
TO COVID-19: CHSBC STUDENTS AND PARENTS**

The Fair Lawn Jewish Center/Congregation B'nai Israel (FLJC/CBI) and the Jewish Community Center of Paramus/Congregation Beth Tikvah (JCCP/CBT) (collectively Synagogues) have put in place preventative measures to reduce the spread of COVID-19; however, the Synagogues cannot guarantee that you or your child(ren) who attend Community Hebrew School of Bergen County (CHSBC) classes or events at the Synagogue will not become infected with COVID-19. Further, your child(ren) attending CHSBC classes at the Synagogues (including when inside the building and outside on the grounds or participating in CHSBC related activities) could increase the risk of your child(ren) or you of contracting COVID-19. You acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that your child(ren) or you may be exposed to or infected by COVID-19 by your child(ren) attending CHSBC classes at the Synagogues or participating in CHSBC related activities, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. You understand that the risk of your child(ren) or you becoming exposed to or infected by COVID-19 from attending CHSBC classes at the Synagogues or participating in CHSBC related activities may result from the actions, omissions, or negligence of yourself and others, including, but not limited to, the Synagogues' employees, officers, trustees and volunteers, and participants in CHSBC related activity.

You, on behalf of your child(ren) and for yourself, voluntarily agree to assume all of the foregoing COVID-19 risks and accept sole responsibility for any COVID-19 injury to your child(ren) or you (including, but not limited to, personal injury, disability, and death, illness, damage, loss, claim, liability, or expense) of any kind, that your child(ren) or you may experience or incur in connection with your child(ren) attending CHSBC classes at the Synagogues (including when inside the building and outside on the grounds) or participation in CHSBC related activities (Claims).

On behalf of your children and on your behalf, you hereby release, covenant not to sue, discharge, and hold harmless, the Synagogues, their employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. You understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Synagogues, their employees, officers, trustees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after attendance at CHSBC classes at the Synagogues (including inside the building and outside on the grounds) or participation in any CHSBC related activity.
